



Agreement between the supplier and DOLL Fahrzeugbau AG

In general:

Company name: _____ hereinafter referred to as supplier
DOLL Fahrzeugbau AG hereinafter referred to as client

Secrecy, trade mark rights

1. The supplier is obligated to maintain all knowledge about the manufacturing processes of the client etc., as for example commercial and technical information or knowledge of which the supplier becomes aware through our business relationship as business. In particular these information which stands in connection with the preparation of an offer, the execution of the order, including all drafts, models, samples, tools and similar objects may not be provided to or otherwise made accessible to unauthorized third parties. Furthermore the employees and co-workers of the supplier, which are entrusted with information about the preparation of offers or the realization of orders, are imposed in accordance with the confidentiality agreement and instructed with regard to §§ 17, 18 UWG.
2. The documents which are handed over from the client to the supplier in favour of accomplishing an order have to be handed back forthwith and complete. Data files which were placed by disposal by DOLL are to be deleted entirely.
3. The supplier commits himself to desist any reproduction of parts, assemblies and vehicles which are constructed on the basis of the documents provided by DOLL.
4. The supplier is liable for insuring that third parties are not infringed upon the delivery and usage of the delivery items. Moreover the supplier is obligated to exempt DOLL Fahrzeugbau AG from all eventual damage compensation claims by third parties.
5. A penalty of EURO 100.000 is forfeited for each breach of the conditions stated in the individual paragraphs 1 and 3.
